Town of Brazeau – Regular Board Meeting Minutes Tuesday, January 17, 2012

Call to Order: Chairman Wendt called meeting to order at 6:30 p.m.

Roll Call: Present: Darrell Enix, James Hanna, Ryan Wendt. Absent: None

Pledge of Allegiance: Chairman Wendt led the pledge of allegiance.

Agenda: James Hanna moved to approve the agenda as presented. Second of motion by Darrell Enix.

Vote: Enix-yes, Hanna-yes, Wendt-yes. Motion carried.

<u>Minutes of December 20, 2011:</u> Darrell Enix moved to accept the minutes with one change on page thee under caption: Notice of Circumstances of Claim, that the word project to be stricken. Second of motion by James Hanna. Vote: Enix-yes, Hanna-yes, Wendt-yes. Motion carried

REPORTS:

<u>Financial Report:</u> Clerk Grosse read the financial report prepared by Treasurer Karen Enix. Page three disbursements for December 2011 \$45,750.05, revenue \$6,962.39, advanced taxes collected \$1,232,368.26, cash on hand as of December 31, 2011 \$1,264,373.72. Clerk stated she has reconciled with the treasurer.

<u>Rescue Squad Report</u>: Sue Kanack stated that squad unit #2 had maintenance conducted this month. Brazeau Squad has been invited by the Mountain Rescue Squad for snowmobile incident training. Brazeau Rescue Squad had 5 calls and 3 transports.

<u>Fire Department Report:</u> Chief John Fetterly stated that 5 members of the fire department are retiring. Firefighters will be attending a volume of training in February and March as much as 3 nights per week. <u>Clerk's Report:</u> Clerk completed two required 2011 training sessions with the Brazeau's poll workers. She stated she is preparing for Spring Primary on Feb. 21st, 2012. Clerk will be attending training at courthouse on Jan. 18th. She is presently working on all year end reports and will be starting the State Municipal Financial CT Report.

Public Comments:

Keith Taylor: Taylor spoke in regards to Pickeral Lake public walkway. He feels a survey should be executed and the pathway needs signage stating No Motorized Vehicles on Pathway. Also, individuals have been pushing snow onto the pathway limiting walking.

Jim Kuchenbecker, Sr.: Mr. Kuchenbecker stated there should be tax collection hours in December since individuals like to pay their taxes prior to year end. There also should be tax collection hours in January. Gale Wogsland: Mr. Wogsland stated the lot where the landing extends to the public walkway on Pickeral Lake should be marked better. Since the town has taken responsibility of ownership it needs to identify what is private and what is public and where the lines are.

UNFINISHED BUSINESS:

M&O Surveying and Assessing – Jerry Pillath

Pillath distributed material received from the Department of Revenue on notice of assessment training. Pillath informed the town board that the town has been out of compliance for the last four years in the classification entitled undeveloped, agricultural, forest and wildlife lands. In 2012 the town will need to execute an adjustment so the value of this property class to fall within the 10% criteria. Pillath proposes the 2012 Board of Review for the Town of Brazeau be held in September due to the timeline of receipt of relative information from the Department of Revenue. Pillath also stated that the Wisconsin Department of Revenue is developing a Uniform Standard of Professional Appraisal Practices and assessors will be receiving a template shortly.

Cell phones highway/road maintenance employees & town plan: Board members reviewed data received from JimWegner of the Suring Cellcom store. Clerk stated that since the data was received the Fire Department decided to drop their cell phone from the town plan. Darrell Enix moved to remain with the existing Cellcom plan and purchase three phones at \$79.95 each less the \$25.00 discount per phone. James Hanna seconded the motion. Vote: Enix-yes, Hanna-yes, Wendt-yes. Motion carried. Employee Grievance Procedure per Wis. Act 10: Chairman Wendt has contacted WTA attorney Carol Nowracki in regards to the grievance procedure to which she stated you do not have to state who the town will be using as a hearing officer. ChairmanWendt paraphrased it should state: "Hearing officer": means the impartial hearing officer required pursuant to s. 66.0509(1m)(d)2, Wis. Stat. The hearing officer will be selected by the Town of Brazeau Board at the time of need. Under the section Hearing officer fee it was decided to remove last line of the paragraph in the template.

Stauber informed board that bonds coming due April 2012-Brazeau Fire Department \$154.00 and Dive team \$125.00. Board advised Norb Stauber that they would like a quote for Fire Department, Rescue Squad and Dive Team coverage. <u>Item to Dispose of Fire Department – Drop Tank:</u> Fire Department has drop tank removed from old tender. Fire Chief Fetterly stated that he has a request of purchase from a small fire department in the amount of \$200.00. Darrell Enix moved to sell drop tank for \$200.00 to the noted buyer. James Hanna seconded the motion. Vote: Enix-yes, Hanna-yes, Wendt-yes. Motion carried.
