i. Call to Order

Financial

The written financial report was presented by Clerk Kriescher. Operating Funds balance as of December 31, 2021 was \$2,261,046.27 Donation Fund Savings \$480.46; Fire Department, Ambulance and Dive Account Funds are \$71,5943.19, bringing a total town balance to \$2,333,120.92.

Ambulance

Debra Agate was present for the Ambulance service, she stated they have had a lot of calls this past month with one mutual aid call in Lena. The service will be doing a training on silent strokes.

John Fetterly presented the fire department report. The department had one mutual aid call with Stephenson. The fire department has two new officers Don Duddek and Gage Radloff serving as Lieutenants. They are also trying to plan a possible training with the dive team.

1. Mailbox Ordinance and Possible Action

Clerk Kriescher stated that the post office has changed their requirements for new addresses and the mailboxes they can put up, with the new requirements a mailbox will cost around \$80.00. The current mailbox replacement ordinance states that the limit for a replacement box would be only \$25.00, so it was asked of the board if the ordinance should be amended. Motion was made by Fetterly/Gretzon to change the wording of the ordinance to state the Town of Brazeau will replace the damaged mailbox with a standard or oversized mailbox based on the size of the damaged box, another motion was also made by Fetterly/Gretzon to add the following paragraph to the ordinance: If any mailbox does not meet the required setbacks by this policy the Town of Brazeau will not replace the mailbox.
