The Town Board of the Town of Brazeau, Oconto County, Wisconsin, resolves and adopts by a majority of the Town board on a roll call vote with a quorum present and voting and proper notice having been given, declares as follows:

The public way subject to this Order lies in the Town of Brazeau, Oconto County, in Block 8 of the Wallschlager and Woogs Subdivision of Rost Lake, Section 23 & 24, T30 N, Range 19E.

The Town Board of said Town having conducted proceedings under Wis. Stats. §66.1003 for the purpose of discontinuing the above-referenced public way or portion thereof;


BE IT HEREBY ORDERED BY SAID TOWN THAT the following described portion of the aforementioned public way is hereby discontinued.

LOCATION/DESCRIPTION: Lot 2, Certified Survey Map Number 1049, being Lots 5 & 6 and unimproved and discontinued roads in Block 8 of the Wallschlager & Woogs Subdivision of Rost Lake, Sections 23 & 24, T30N, R19E, Town of Brazeau, Oconto County, Wisconsin. The area is further described on the attached Exhibit A, Surveyors' Certificate, Jeffrey M. Lieuwen.

BE IT FURTHER RESOLVED, that upon the discontinuance of a portion of the public way in the Town of Brazeau, Oconto County, Wisconsin as described above the title of said land shall revert to the abutting property owners and said land shall be at the expense of the abutting property owners and not the Town of Brazeau.



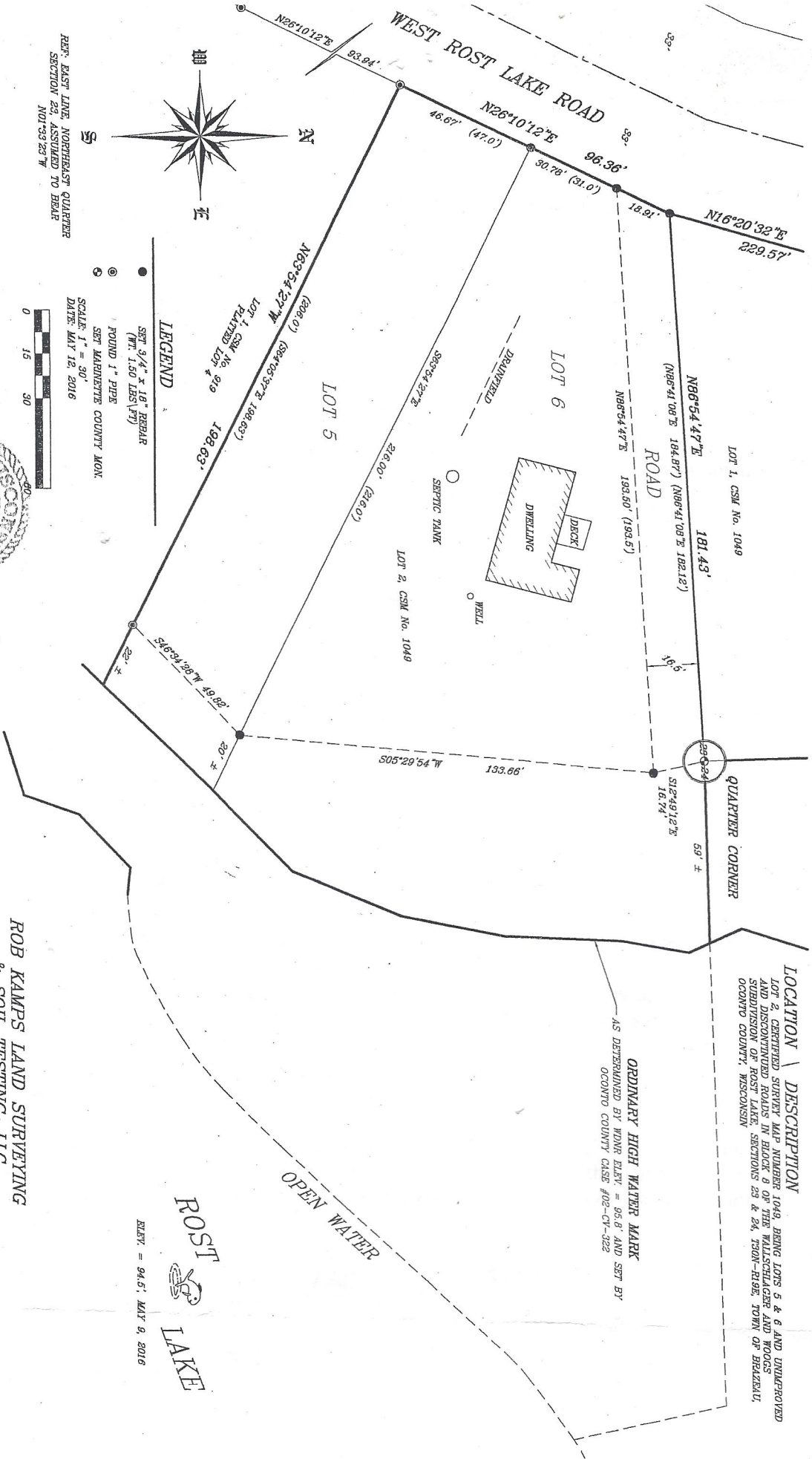
