OLD BUSINESS

Lights and Sirens: We have updated lights and sirens protocol from the township. By-Laws: Went through addendums made to by-laws. The following changes were made:

Original addendum stated: Section 11: The squad will provide uniforms i.e.; shirts, pants jackets) to the members at no charge. Equipment i.e.; radios, portables/with chargers, AED, jump bag must be returned when member retires, resigns, or extended leave of absence. (7/2016)

This was changed to: Section 11: The squad will provide uniforms i.e.; shirts, pants jackets) to the members at no charge. Equipment and uniforms i.e.; radios, portables/with chargers, AED, jump bag must be returned when member retires, resigns, take extended leave of absence or terminated. (7/2016)

Article XI: Grievance Procedures Addendum was addressed and changed per member recommended wording. Original addendum stated: Addendum: "TERMINATION OF MEMBERSHIP" The president shall recommend to the Town of Brazeau Board to demote, expel, or terminate any officer or member for the Brazeau Ambulance for:

- a) Physically unable to perform duties.
- b) Failure to participate in departmental meeting, drills, and activities. (All members are required to follow Article III, Section 4 for attendance)
- c) Neglect or refusal to perform his or her duties.
- d) Conduct endangering other safety or well-being.
- e) Violation of the by-laws of the Brazeau Ambulance.
- f) Stealing from the Brazeau Ambulance.
- g) Operating an emergency vehicle or present at an incident scene while under the influence or apparent influence of alcohol or drugs. (Guideline of 8 hours prior)
- h) Questioning the conduct or ability of other members of places other than Brazeau Ambulance meetings or to people other than the Brazeau Ambulance members so as to lower the reputation of another member.
- i) To behave in a non-professional manner that is unbecoming of a Brazeau Ambulance member.
- j) Operate any emergency vehicle without due regard of all traffic laws. 7/2016 **This was changed to: Addendum: "TERMINATION OF MEMBERSHIP**" Recommendations of officers and then presented by president to the Town of Brazeau Board to demote, expel, or terminate any officer or member for the Brazeau Ambulance for:
- k) Physically unable to perform duties.
- l) All members are required to follow Article III, Section 4 for attendance.
- m) Neglect or refusal to perform his or her duties.
- n) Conduct endangering another's safety or well-being.
- o) Violation of the by-laws of the Brazeau Ambulance.
- p) Stealing from the Brazeau Ambulance.
- q) Operating an emergency vehicle or present at an incident scene while under the influence or apparent influence of alcohol or drugs. Zero tolerance for drugs and alcohol.
- r) Questioning the conduct or ability of other members or emergency calls outside of official ambulance meetings or reviewing.
- s) To behave in a non-professional manner that is unbecoming of a Brazeau Ambulance member while in official capacity.
- t) Operate any emergency vehicle without due regard of all traffic laws. 7/2016
