#### Special Town Meeting of the Electors March 21, 2017 - 6:00 p.m.

<u>Call to Order</u>: Town Chair, Ryan Wendt called town meeting to order at 6:00 p.m.

<u>Roll Call of Board Members</u>: Present: D. Parmentier, S. Thomson, R. Gretzon,

G. Kempka, R. Wendt. Absent: None



BUSINESS: Elizabeth R. Washebek Memorial Building

Town Chair, Ryan Wendt, read the Special Town Meeting Notice aloud. The purpose of the special town meeting is for the purpose to consider the budget for the Elizabeth R. Washebek Memorial Building. Chair referred to Special Town Meeting of the Electors; November 5, 2015 containing motion to approve building construction with a cap of \$300,000 and not to bid out until 2017. Minimum bids less bid for holding tank for catch basins not yet opened equated to \$301,046.50.

Bev Rock express approval of project since as stated only \$1,000.00 over the approved \$300,000. Chair reiterated that some things could go over and proposed contractor has expressed certain areas of change orders and would reduce the original bid. Question from the floor inquired if town has taken into consideration cost of bringing power into the project location. Chairman responded; no. Hosking Electric stated estimate at \$1,000. Jamie Wallace inquired if town putting internet in the building. Presently the ambulance units have wireless. Pam Duddek asked how much of the funds does the town have available at this time. Chair expressed 2017 budget holds \$100,000 and last year's budget held \$100,000. Supervisor, Gerald Kempka informed electors that the Ambulance, Fire Department and Dive has agreed to place all profits received from the fundraiser picnic to be placed toward this project. Jim Kuchenbecker asked what is the total cost; Chairman expressed until holding tank bid opened total is undetermined at this time. Jim Rock inquired as to the best way to word the motion; to state motion to cover building and reasonable overages. Chairman, expressed such motion would be open to interpretation. Roy Lawrenz expressed suitability of steel over aluminum in building construction. Savings at this time may not be beneficial in the future. Tom Grosse expressed calculating the \$300,000 with a 5% contingency.

Motion-Jamie Wallace to approve construction Elizabeth R. Washebek Memorial Building as a whole; acknowledging bids already reviewed and presented; and, building project not limited to \$300,000.00. Second-Roy Lawrenz. Discussion: Mark Rost, contractor disclosed proposed savings areas of the project; estimate range of \$9,000.

Hand Vote: Aye: 29 - Nay: 3. Motion carried.

ADJOURNMENT: Motion-P. Duddek/Second-V. Parmentier to adjourn. Meeting adjourned at 7:27 p.m.
