<u>Brazeau Fire Department:</u> Fire Secretary-Treasurer, Jim Kuchenbecker Jr reported response to a grass burn and department pursuing a DNR grant for brush truck.

<u>Dive Team:</u> Town chair received contact from captain that dive plans to paint exterior of former ambulance building and would like to host an open house.

<u>Highway</u>: T. Grosse reported highway crew has installed 26 warning signs' hope to execute road patch as weather become more conducive.

NOCCO Committee Update: 7 towns finalizing individual town ATV ordinance; each working on traffic and boating ordinances. Received update from Dusty Trails on ATV signage state proposed changes.
