Meeting Called to Order by John Kussow at 12:03 pm

A motion to dispense reading and accept the October Meeting minutes as published was proposed by Sue Kanack and seconded by Mandi Fonder and carried.

Financial Summary recap of \$37,525.35 in Budget Account and \$29,934.19 in Ambulance Service Checking Account was presented by Keri Warrichaiet.

Motion to accept the budget was proposed by Mandi Fonder, seconded by Sue Kanack and carried.

Old Business:

- 1. Schedule. John Kussow mentioned the large print out of the schedule was not available so please go online and schedule for at least 16 hours per month.
 - John Kussow asked all members present to please sign in for meeting and training today.
- 2. Jim Kuchenbecker said the next Fund Raiser to plan for is the Fishing Derby on Kelly Lake, January 13, 2024. All members available are requested to help out because this is a large event and EMS, Fire, and Dive Teams do well at the event.
- 3. John Kussow presented changes to the Bylaws for the second consecutive month. The proposed changes include:

Changing the President title to Service Director.

The Vice President position will be eliminated. Inventory and supplies consumed by the service will be tracked and material requests will be submitted to the Service Director for approval are a part of the full-time employee job description.

The Secretary – Treasurer position will back fill the role of Service Director when the Service Director is not available as a short-term measure. In the event that the Service Director position becomes open long term, the Secretary – Treasurer will fill the role until a person is appointed or voted in by the membership to fill the remainer of the term.

A change to pay structure for the officer position is included in the bylaw changes, but the Town of Brazeau is the approving body. Membership does not vote on officer pay.

Discussion took place and questions and concerns were addressed to attending membership satisfaction.

A motion to accept the changes to the bylaws, subject to the Town of Brazeau Board approval, was made by Sue Kanack and seconded by Jamie Waller and carried.

New Business:

Dusty Agate reviewed the 11 calls that we had the past month. There were three trauma calls: one ATV accident, one automobile accident, and one where a tree fell on a person. Two additional calls had a high potential for hypothermia.

Drivers are reminded that no ambulance should be taken off pavement in the event of an Off Highway Vehicle (OHV) incident. When a patient is off pavement, call the Fire Department to bring the town's UTV for rescue support. During the winter the UTV has tracks to aide with snowmobile accident rescue calls.

A motion to defer nominations for Vice-President and Secretary – Treasurer, based on the acceptance of the bylaw changes by members, and pending approval of the Town of Brazeau board, was proposed by Jim Kuchenbecker and seconded by Jamie Waller and carried.

Nominations for Person of The Year should be sent to John Kussow. The name of the nominee and reason for the nomination should be sent to John Kussow by the end of the December Ambulance Service meeting. The service award for Person of the Year will be presented at the Annual Banquet, on January 19, 2024.
