MEETING MINUTES

March 3, 2024 12:00 pm (noon)

Meeting called to order by John Kussow at 12:00 pm

A motion to dispense with the reading and approve the minutes of the January Meeting was made by Gage Radloff, seconded by Keri Warrichaiet, and carried.

**Finances:** Ambulance Budget: \$93,803.73 Money Market: \$49,498.70

**Old Business**

Discussion to change the ambulance schedule to one file for the entire year was discussed with the membership. The membership approved the change. The new schedule will be sent out and members are asked to fill in their desired schedule. If members are not available for the hours they had previously scheduled themselves to cover, they are asked to remove their names from the schedule.

**New Business**

**WEMSA:** Members that attended the conference found it to be beneficial. Conference lectures attended include: administration, anaphylaxis, and stop the bleed. One new item to watch for is a glucagon intranasal product. The product is not yet approved for use in Wisconsin.

**EMS week is May 19-25, 2024:** Several members agreed to form a committee to work on ideas that we could implement with the goal of increasing membership and improving public awareness. The ambulance service is still in need of drivers.

**Building Grant:** a discussion took place regarding possible updates to the building. Long term goal is to enhance our facility for current crew members and possibly draw in other potential volunteers. A group will investigate possible state and or federal grants to cover the cost and to determine feasibility of improvements.

**Nemesis 3.5** the updated system is operational and no major concerns appear to have surfaced. One change to previous version is to note which paramedic service is used in the narrative, if a paramedic service is called to assist.

**Calls:** There were 8 calls in the past month with very good response time; under 15 minutes, and time on scene assessing patient; under 15 minutes.

**Training:** UW has continuous education training meetings the third Wednesday of every month at 6:30 pm.

We had a good turnout for the joint training session with Coleman Ambulance Service to continue our multiple casualty incident preparedness.

**Oconto County EMS meeting:** The next Oconto County meeting is being held April 3 at the Coleman Ambulance Service at 6:30 pm.

A motion to end the meeting was made by Keri Warrichaiet, seconded by Mario Ruiz, and carried.
