

**TOWN OF BRAZEAU, OCONTO COUNTY**

**Application to Perform Work on Town Road**

The Town of Brazeau requires a minimum \$500.00 cash bond for each incident prior to any town road, shoulder or right of way work; such as, lay pipe, wiring, culverts, tree and brush removal, etc. This cash bond is held until the road work is complete. You have 30 days to repair road back to original condition or better. Upon notification of completion and an approval inspection by the town the cash bond will be returned to the payer. If it happens that the road is left in a condition that needs added work to repair, the cash bond will be used for the repair and any additional costs needed for the repair will be billed to the payer. All public utilities as defined in Wisconsin Statute § 196.01 are required to be bound by the terms and conditions of Town of Brazeau Ordinance 7.0600 as well as all subsections thereunder, except that a public utility as defined by the ordinance shall not be required to post the cash bond.

## Town of Brazeau Ordinance 7.0600-Road Excavation

### **7.0601 Permit Required**

A. No person, company, LLC, utility or corporation, or their agents or employees or contractors shall make or cause to be made any opening, excavation, or boring, or place/relocate/replace any utility structure or pole, sanitary lateral or thereof; in or under any public street, public road/highway, public lane, right-of-way, public ground or town owned easement or fill or alter any culvert or construct or install additions or extensions to its existing facilities within the Town of Brazeau without a permit application filed therefore with the Town Chairperson, or Town Clerk, or their designee.

B. The utility or contractor shall submit to the town a written request for a utility construction/street-road excavation permit and a plan of the proposed alteration, coring, extension or addition, showing its location and details of construction, including specified depth, method of excavation, open our or auguring, provisions of restoration and whatever the town would deem necessary for review and consideration. In granting permits the Town of Brazeau will adhere to Wisconsin Statute § 66.0425

### **7.0602 Cash Bond**

Before a permit of excavation, boring or opening any road/highway/street/lane etc., or public way be issued, the applicant must provide a \$500 bond and a signed statement in that he/she will indemnify and save harmless the Town of Brazeau and its officials from all liability for accidents and damage caused by any of the work covered by his/her "application to perform work on town road" permit and that he/she will fill up and place in good and safe condition all excavation and openings made in the road/highway/street/lane, etc. and will replace and restore the pavement over such opening making it as near as can be to the state and condition in which he/she found it and keep and maintain the same in such condition, normal wear and tear exempted, to the satisfaction of the town board. All public utilities as defined in Wisconsin Statute § 196.01 are required to be bound by the terms and conditions of Town of Brazeau ordinance 7.0600 as well as all subsections thereunder, except that a public utility shall not be required to post the cash bond except for the rule in PSC 130.06.

Whenever the town board shall find that such work has been defective upon notification of completion from such excavator/contractor/public utility and such road/highway/street/lane etc. is not restored as required, the town board will/shall restore the surface and bill the permittee. If the permittee paid a bond they will be billed therefore the cost thereof less the five hundred (\$500) bond (refer to the Town of Brazeau Fee Schedule).

### **7.0603 Emergency Excavation**

In the event of an emergency, any person, firm or corporation owning or controlling any sewer, gas main, water main, conduit or other utility in or under any public road/highway/street, easement, way or ground and his/her agents and employees may take immediate proper emergency measure to remedy dangerous conditions for the protection of property, life, health or safety without obtaining an excavation-permit to work on town road; however, town board member should be notified of such action.

### **7.0604 Protection of the Public**

Every opening and excavation shall be enclosed with sufficient barriers, sufficient warning signs, warning lights, etc. exercising necessary precaution measures against injury or damage to person, vehicles or property of any kind.
