i. Call to Order

Chairman Wendt called meeting to order at 6:30 p.m.

ii. Roll Call

Present: R. Gretzon, J. Fetterly, R. Wendt, R. Nasgovitz,, and C. Kasten present by Zoom

iii. Agenda Approval

Motion by Fetterly/Gretzon to approve the agenda. The motion was voted on and carried. 5-0

iv. Approval of Previous Meetings Proceedings:

Motion was made by Fetterly/Gretzon to approve the previous meeting minutes. The motion was voted on and carried. 5-0

v. REPORTS

1. Financial

The written financial report was presented by Clerk Kriescher. General Fund balance as of October 31, 2024, the balance forward was \$200,956.92. Donation Fund Savings \$481.16; Fire Department, Ambulance and Dive Account Funds are \$107,906.81, bringing a total town balance to \$292,101.77.

2. Ambulance

The ambulance service had no report.

Fire Department

John Fetterly presented the fire department report. The fire department has 3 calls, with some lift assists. They department have completed all their meetings for the year and Fetterly has completed all but 1 fire inspection for the year. John also mentioned during the meeting that there have been 2 big fires at the Darga farms and they contacted him and stated they would either give a donation or donate bucket raffles for the EMS picnic.

Dive Team

Keith Scray was present for the dive team and stated there has been no calls and they are holding their monthly meeting Wednesday, December 18, 2024.

Highway Department

The highway department has plowed twice, burned the brush pile down at the Leaf and Brush center, and set up the ice rink, it is looking pretty good if the weather holds out.

Public Comment

Clerk Kriescher reminded everyone that the Recycle center will be closed both Wednesday, December 25th and Wednesday, January 1st, there is a 7 towns meeting that will be held at the Town of Brazeau Hall on January 15th and she also reminded everyone about the Noon Years Eve Party that will be held at the Ambulance building on December 31st. Craig Kasten mentioned for the clerk to look at the possibility to make it easier to find the agendas on the website, the clerk will investigate this.

ACTION ITEMS

1. Plan Commission-Rezone

Motion was made by Nasgovitz/Fetterly to approve the rezone for Daniel Rysewyk. Mike Luebke and Paul Shallow were present and said there are 9 lots on Rost Lake and Daniel would like to combine all parcels to one, most of the parcels are zoned residential, but some are agriculture and Daniel wants to rezone all to residential. Motion was voted on and carried. 5-0

2. Brazeau Sanitary District Transitioning into a 5 person board, Appointments, and Ordinance

Motion was made by Fetterly/Gretzon to approve the amendment to Ordinance 4.0400 (Brazeau Sanitary District). Motion was voted on and carried. 5-0

Motion was made by Fetterly/Gretzon to approve the addition of 2 more commissioners, John VandenElzen and Pam Johnson, the Sanitary District will decide on the length of all terms. Motion was voted on and carried. 5-0

3. Dive Team Quote for New Boat Motor

Keith Scray had obtained a quote for a 25 HP, 4 stroke, fuel injected Yamaha motor for the dive team at a cost of \$5,437.00, he also stated that Power Sports would give him a trade in of \$500 for the old boat motor. Motion was made by Fetterly/Nasgovitz to purchase the new motor for \$5437.00 and sell the old one for \$500. Motion was voted on and carried. 5-0

4. Library Seat Availability

No one has come forward with any interest in serving on the Suring Library board. The board members have decided to leave the seat open for now until someone comes forward with some interest. No motion needed.

5. Approve Short-Term Rental Application

Motion was made by Fetterly/Nasgovitz to approve the STR application for Ryan Champeau. Motion was voted on and carried. 5-0 Craig Kasten brought up that one of the STR owners only has 1 property licensed with the town, but operates 2 STR in the Town of Brazeau. Kasten asked if the clerk could email our officer regarding this matter.

LOSA Contribution

Motion was made by Kasten/Nasgovitz to approve the town contribution for each LOSA member at \$495.26 for the year. Motion was voted on and carried. 3-0 with Fetterly and Gretzon abstaining.

7. Right of Way Work Along Weier Lane

Ryan Wendt had brought this to the board stating he is going to have some work done at his farm next year and would like to install a culvert and do some ditch work along Weier Lane, which would include some work in the town right of way making the ditch a 3:1 slope. Mr. Wendt stated all cost would be covered by him. Motion was made by Fetterly/Gretzon to approve this work. Motion was voted on and carried. 4-0 with Wendt abstaining

8. Park Planning

Chair Wendt would like the board to approve the cost for Ayres to make a park plan located at 12128 Parkway Rd, Nasgovitz stated we should finish developing the park in Klondike, it was mentioned if we put more things down in Klondike parking would then become an issue. Motion was made by Gretzon/Fetterly to approve the start of park planning with Ayres. Motion was voted on and carried. 4-1 with Nasgovitz voting no.

9. Emails and Laptops

Nasgovitz and Kasten brought up the fact that supervisors and residents who serve on different commissions should not be using their personal emails, due to complications with Open Record Requests. Clerk Kriescher will look into secure and separate emails and see what other towns are doing for their supervisors. No motion needed.

10. Budget and Possible Amendment

Clerk Kriescher presented a budget amendment which included increasing revenues, decreasing expenditures and decreasing the general fund for a total of \$119,379 and then increase expenditures for a total of \$119,379, because this is a large amendment the clerk will include this amendment with the minutes for the month. Motion was made by Fetterly/Gretzon to approve the amendment to balance the budget for the year. Motion was voted on and carried. 5-0 Roll Call vote take with all 5 board members voting yes.

vi. December 2024 Wage and General Vouchers

Motion was made by Fetterly/Kasten to approve the December 2024 wage and general vouchers. Motion was voted on and carried. 5-0 Clerk Kriescher also has permission to use Kasten's stamp on all checks and transfers.

ix. Set Next Meeting

Next town board meeting will be held on January 21, 2025 at 6:30 pm, with the 7 towns meeting being held at the Town of Brazeau on January 15, 2025 at 6:30 pm.

vi. Adjournment

Motion was made by Gretzon/Nasgovitz to adjourn. Motion was voted on and carried. 5-0 Meeting adjourned at 7:35 p.m.
