Keri Warrichaiet made a motion to cast a unanimous ballot for Deb Agate to remain as Training Officer, seconded by Nancy Warrichaiet and motion carried.

New Member: Pete Schwenke was voted to become a regular member of Brazeau Ambulance as a driver.

<u>Donations:</u> Kudick Garage (Coleman) donated a battery for 8082. A thank you note was hand delivered.

<u>Call Review:</u> 14 calls, 14 patients; 12 transports, 3 paramedic intercepts, 2 no transport/refusal. There were two follow up calls from families, both complimented the staff members on the calls in addition to a patient update.

<u>Person of the year:</u> There were three nominations for Person of the Year: Michelle Brittnacher, Don Duddek and John Kussow. Votes were cast and the winner will be announced at the January 17<sup>th</sup> Brazeau Emergency Services Dinner. Congratulations to all nominees, we are truly blessed to have them on the service.

## **New Business Member Comments**

<u>WARDS (billing):</u> We are to have only one Primary on the report and the rest are secondary. Each medical personal (EMT, EMR) is required to enter their findings to the narrative, sign on the signature page and complete the report within the 48-hour period from the time of the run. PNB calls need to be billed out ASAP due to the Coroner needing the report right away.

<u>HIPPA</u>: Reminder to avoid a HIPPA violation, calls are not to be talked about with others outside the immediate crew. Calls may be discussed at the meetings for training purposes. We are not to disclose any information regarding a call even if the questioning party had information that they would like confirmed. Talking to others about the call example: spouses, neighbors, or family would be considered a HIPPA violation.
