MEETING MINUTES October 6, 2024 9:00 am

Meeting called to order at 9:03 am

Minutes of last meeting

Motion to dispense with the reading and approve the minutes from the September 8, 2024 meeting was made by Jim Kuchenbecker, seconded by Michelle Brittnacher, and carried.

Old Business

Update on radio switch from Oconto EMS meeting: Updates are expected in December. Jon Spice will ensure our radios are updated at no expense to us.

K9 Medical Training is being offered November 13, 2024 at the Oconto Fire House from 5-9 pm with 1 spot for Brazeau Rescue remaining. Deadline to confirm is 10-23-24; let Dusty know this week if you would like to attend as the registration will be completed by Friday.

LifeVac choking masks were purchased and will be in each rig. Dr. Salmi has been notified of the intended use. Members who will first respond to calls are eligible for one.

Fund Raising report: Reminder of ice fishing derby in January. They are still looking for a band, so if you have any ideas let Jim know.

Recruitment: There will be an EMR class in January in Oconto Falls.

Shirts: Reviewed shirt options on the cabinet. We will try to get some samples for people to look at but in meantime, make sure, when possible, you have a Brazeau EMS/Fire shirt on when responding to a call.

Current membership policy and procedures requires 16 hours on the schedule each month. DHS 110.34 requires coverage 24/7 365 days a year to run the service. The written schedule is used to demonstrate the

service is meeting these requirements. We have 1440 hours of EMS coverage needed each month. Right now, even if every EMS person does the 16 hours minimum, we are over 1200 of coverage short each month. Please put yourself on the schedule when you can.

Vacations/absences: If you know you will be unavailable for a longer period of time, please let fellow members know through I am responding and put the dates on the calendar on the front desk.

The new PCR with changes from last meeting was reviewed and will be put into effect Monday. Please share feedback at the next meeting.

Supplies – The Rig phones will be upgraded to ATT First Net for better reception.

New Business Member Comments

Gage provided an update from the Marinette County EMS meeting last week.

There is a new drug W18 that is 100% stronger than Fentanyl. It is a pain killer from Canada used as a cutting agent.

He also provided yellow hazard bags to put any chemo supplies in should we respond to a call with someone treating at home with chemotherapy. These medicines can be toxic and it is recommended you double glove when dealing with these patients.

A reminder from Marinette County Dispatch when requesting a paramedic intercept be sure to wait for dispatch to respond to your call before providing details.

Rainbow house provided materials about identifying strangulation cases and requested be more detailed in narratives describing the actions and not just saying patient was "choked."
